1. INFORMATION WE COLLECT

When you visit our Site, we may collect the following types of information:

Information You Voluntarily Provide: We collect the personal information you provide when you use our services or otherwise communicate with us, such as when you provide contact information, or send us an email. Our services are not directed to children, and we do not knowingly collect personal information from children under the age of 13.
