

Privacy Policy - Little Stars Childcare

1. INFORMATION WE COLLECT

When you visit our Site, we may collect the following types of information:

Information You Voluntarily Provide: We collect the personal information you provide when you use our services or otherwise communicate with us, such as when you provide contact information, or send us an email. The types of information we may collect include your name, email address, postal address, and telephone number.

Automatically Collected Information: When you access our Site, we may automatically collect certain information about your device and usage of our Site, including your IP address, browser type, device type, operating system, page views, referring URLs, destination URLs, dates and times of site visits, and other such information. We may use cookies, pixel tags, web beacons, or other tracking technologies to collect this information.

We may share the information we collect in certain circumstances, including the following:

Legal Requirements: We may disclose your information if required to do so by law or in the good faith belief that such action is necessary to comply with a legal obligation, protect and defend our rights or property, protect the personal safety of users of the Site or the public, or protect against legal liability.

We take reasonable measures, including administrative, technical, and physical safeguards, to protect your information from loss, theft, misuse, unauthorized access, disclosure, alteration, and destruction. Our services are not directed to children, and we do not knowingly collect personal information from children under the age of 13.
