Purpose of the job:	To work as part of a small team in our Forest Kindergarten. You will help to provide an exciting, magical and high quality early years experience for the children in a woodland setting.

3. Help us to promote a happy, caring and welcoming atmosphere.
4. To take on increasing responsibility for a small group of children as time goes on, ensuring they have access to and participate in a range of outdoor learning and play opportunities.
5. Assist with the recording and reporting of children's learning, care and development.
6. To be aware of and follow all Treehoppers policies and procedures.
7. Support snack/meal times within the setting.
8. Support children with hygiene & personal care.
9. Actively participate at team meetings & supervision meetings. We are a small team and value everyone's ideas, thoughts, creativity and suggestions to make our setting the best it can be.
10. To keep completely confidential any information regarding the children, their families or other staff, which is acquired as part of the job.

2. Enjoy working with young children and have some experience (this can be voluntary)
3. Happy to sing songs, play games and be really enthusiastic about mud soup, mud tea, worms, sticks

and leaves

4. Some knowledge & understanding of child development from two to five years and the Early Years Foundation Stage (EYFS)
5. Ability to work in a way that promotes the safety and wellbeing of children.
6. Understanding of the Forest School ethos.
7. Good communication skills.
8. Good team player.
9. Able to organise own transport to and from Treehoppers.
